

AGREEMENT BETWEEN

The agreement between Lamento Rumeno Onlus and The Nature – A Heritage for the Future, hereby mentioned as “Nature” has validity from July 2008 till December 2008.

At maturity, Lamento Rumeno Onlus and Nature will decide to renew the agreement or to end the collaboration.

Nature gives the authorization to Lamento Rumeno Onlus to promote the adoptions at distance concerning the dogs hosted in Popesti shelter.

Nature gives the authorization to Lamento Rumeno Onlus to visit the shelter; date, reason and conditions of the visit must be agreed in advance.

Lamento Rumeno Onlus is willing to support Nature to buy 1.000 kg dry dog food/month.

Lamento Rumeno Onlus is willing to support Nature giving a contribution for the sterilizations and vaccinations; terms and conditions will be settled when Nature will submit a concrete program to Lamento Rumeno Onlus.

To request a contribution for food, medicines, goods (etc.), Nature will apply to Lamento Rumeno Onlus, filling the special form (n. 1)

Lamento Rumeno Onlus after considering the request, will accept it or reject it within 7 (seven) days.

The invoices/receipts paid by Lamento Rumeno Onlus must be addressed to Lamento Rumeno Onlus.

Lamento Rumeno Onlus will not provide to pay the invoices/receipts addressed to another association or individuals.

Lamento Rumeno Onlus will provide to pay the invoices/receipts within 10 days on receipt of the documents.

For the invoices or receipts paid by Lamento Rumeno Onlus, Nature will send a copy of the documents to Lamento Rumeno Onlus attaching a declaration to confirm that Lamento Rumeno Onlus has provided to the payment.

Nature will provide to update Lamento Rumeno Onlus sending a monthly report.

The report must be send within the last day of each month, filling the special form (n. 2) including pictures.

All the fiscal documents and the declarations sent by Nature to Lamento Rumeno Onlus will be available for donors to justify the use of their donations collected by Lamento Rumeno Onlus.

Also a report of the transfers for the financial support gave to Nature by Lamento Rumeno Onlus will be available for the donors.

In case of non-fulfilment of the terms and conditions mentioned above, the collaboration between Lamento Rumeno Onlus and Nature Association will be break off immediately.

Nature commits itself to mention the collaboration with Lamento Rumeno Onlus on its website when it will be completed.

The agreement will be implemented or changed if Lamento Rumeno Onlus and Nature will consider it necessary
